Pension Fund - \$3.72 per hour, 60% Apprentice

Pension Fund - \$4.65 per hour, 75% Apprentice

Instructions for Monthly Remittance Reports

The National Pension Fund (1.45) and International Training Fund (.10) should be mailed directly to the NPF at PO Box 62031, Baltimore, MD 21264-2031. One check can be issued to the National Pension Fund for both funds.
